If we get rid of Summer, should we adjust our Spring schedule (potentially start Spring Season after Spring Break; ask clubs). Discussed how adjusting schedules would impact other counties.
 - i. Discussed sorting techniques (such as promotion/relegation).
 - ii. Discussed importance of league manager participation at sort meetings. Out of county leagues are now required to have a representative present.
- **b.** Rec Cup Status: No one is stepping forward to run this. Need to go to the other counties and see if they have volunteers and the go back to WYSA to advise them. Lack of support Not much interest in this continuing.

b. **Referee Rate (Summer 2023 and beyond):** Our Summer rates historically have been lower than other seasons because summer games are shorter. This issue was never ratified when we discussed referee increase in rates. The expectation is they will be prorated. This reduction is typically \$4 per game.

- c. **Questions for Jeff Line:**
 - i. Use Slack for communication vs. email. Would like to show Slack to the group next meeting and add it to the agenda.
 - ii. Remove Virtual Link: Looking into Microsoft teams.
- **d.** Referees for U8: Discussion around referees for U8 given issues surrounding behaviors. Thinks the Ironman pay has helped with coverage. Overall, we are at 90% coverage, things are trending in the correct direction. Concerns over adding the U8 teams and spreading the referees thin. We made this decision to remove U8 referees and didn't explore a supportive solution for these games. We have concluded with our discussion that we cannot do U8 referees again and thin out coverage for older age groups.
 - i. How can we control behaviors at the U8 games without adult supervision? We discussed getting a message to all of the clubs to disburse to the teams. Discussion around field marshals at the games. Clubs need to ensure all of the rules are being universally understood. Let's check in next meeting re: U8.
 - **ii.** Mike Brackett, DOC, will draft a circulate a policy regarding how to handle games with no referees present.
 - **iii.** Discussion from Devin around training of new referees. And issues with having referees that can train others.
